Tenure of engagement	(i) The initial tenure of engagement of Consultants (Doctors in Medical Disciplines) would be for a period of 01 (one) year, which can be further extended for a period of one (01) year at the discretion of the Company. The maximum period for engagement under the same would not be more than three (03) years. However, there will be no bar on re-engagement. The tenure of engagement shall be subject to the upper age limit of 70 years.
